HCR's Office of Rent Administration (ORA) has a "Ask HCR web portal" where tenants in NYS can ask if an apartment or building is rent stabilized and/or request an apartment's rent history. Alternatively, tenants can use the HCR's Rent Connect portal to request a rent history.

## NYC's Lawful Source of Income Discrimination Campaign

It is illegal in New York City for landlords who own buildings with six or more units or real estate brokers to refuse to rent to current or prospective tenants with rental assistance vouchers. Under NYC Human Rights Law, lawful source of income includes any federal, state, or local public or housing assistance towards the payment of rent, including housing subsidies like Section 8, HIV/AIDS Services Administration (HASA), FHEPS, and CITYFHEPS, among others. It is also unlawful for landlords and housing agents to publish any type of advertisements, including online or print, that indicate a refusal to accept these programs.
