Individuals must have a household income at or below HEAP guidelines (Tier 2) to be eligible.

### Tier 1 Guidelines

These guidelines are set at 130% of the federal poverty level. Households with incomes below the Tier 1 income guidelines receive a slightly higher HEAP benefit amount than those households with incomes below the Tier 2 guidelines.

#### Tier 2 Guidelines

For household sizes 1-10, guidelines are based on 60% of the state median income. For households with 11 members or more, the income guidelines are set at 150% of the federal poverty level.
